Student Grant (2020-2021 School Year)

The HKSAR Government has decided to regulate the provision of students' grant starting from the 2020/21 school year. All students studying in secondary day-schools, primary schools as well as kindergartens are eligible for the grant. The student grant will be non-means-tested. Applicants are not required to provide other documents at this stage. Applicants will only be required to provide documents when necessary.

The completed forms must be submitted through school. No duplicated application is allowed. The subsidy will be disbursed to parents via local bank transfer.

The EDB will distribute the "Student Grant" Application Forms and verify the student status via schools.

Form A (Blank Form)	Applicable to the following students: 1. P.1 students or 2. Students who are newly admitted to the school in this academic year (P.2 to P.6) or 3. Students who have not applied for the student grant before or 4. Students with the essential particulars (i.e. Name in English, Name of Day-school or School Level) requiring amendment
	Applicants may refer to the reference information uploaded onto the EDB website 1. Bank code list 2. Video clip about how to complete the application form (Please scan the QR code) 3. Form A (Sample)
Form B (pre-printed with the basic information of the student as well as that of the applicant)	Applicable to students who applied for the student grant before 1. Parents/guardians are only required to check the accuracy of the pre-printed information. 2. Put a "✓" in the confirmation box at the bottom part of the form and sign to confirm if there is no change in the information pre-printed. 3. If some of the pre-printed information on Form B requires updating (information other than Student's Name in English, Name of Day-school and School Level), parents/guardians have to provide the amendment(s) in the space above the relevant information in BLOCK letters using black or blue ball pen, and leave the confirmation box blank.



Applicants should read the 'Notes to Complete this Form' and the 'Declaration' carefully before completing the application forms. Please return the signed reply slips and the completed application forms to your class teacher on or before 16th October, 2020 (Friday). Those parents who choose not to apply for the grant are also required to submit the signed reply slip and the application form to your class teacher. (In this case, please leave the form blank.)
