**Arrangements for “2021/22 Seasonal Flu Vaccine School Outreach (Free) Program”**

To encourage children to receive seasonal influenza vaccination in schools to protect their health and increase their vaccination rate, the Department of Health launched the "Seasonal Influenza Vaccine School Outreach (Free) Program" in the 2021/22 school year. Our school will participate in this program this academic year, and arrange vaccination teams by private doctors/medical institutions participating in this program to provide free outreach influenza vaccination services for students. Details are as follows:

Date	First dose: 25 <sup>th</sup> November, 2021 (Thursday)
	Second dose: 21 <sup>st</sup> January, 2021 (Friday) *Students who are 9 years old or below who have not been vaccinated for influenza will require a second injection
Venue	School Hall
Fee	Free
Medical Institutions	HEALTH & TREASURE INTERNATIONAL COMPANY LIMITED
Remarks	If the student fails to receive the vaccine due to absence or discomfort on the day of the vaccination in the school, parents can also arrange to visit private clinics participated in the "Vaccine Subsidy Scheme" for reinjection (free of charge). The list of related doctors and clinics and their fees have been uploaded on the website of the Centre for Health Protection ( <a href="https://apps.hcv.gov.hk/Public/en/SPS/Search">https://apps.hcv.gov.hk/Public/en/SPS/Search</a> ).

The vaccination service is self-voluntary, the consent form is distributed together with this circular. Parents please read and fill in the consent or disagreement form and flu injection record (if any), and return the entire page (**do not tear it apart**) to the class teacher on or before **Wednesday, 29<sup>th</sup> September**.

If parents agree with their children’s vaccination, but the student does not hold a Hong Kong birth certificate or Hong Kong ID card, a copy of the student’s identity document (birth certificate/passport/re-entry permit/document of identity for visa/ Others) must be submitted for the collection of information by the Vaccination Team of the Department of Health.

**If the student has received the COVID Vaccine within 14 days before the seasonal flu vaccine, they are not suitable to receive the seasonal flu vaccine.**
