Arrangements for “2021-2022 Student Grant”

Starting from the 2020/21 school year, the Hong Kong Special Administrative Region Government will make the student grant of \$2,500 a regular scheme. All students studying in secondary day schools, elementary and special schools and kindergartens under local or non-local courses in Hong Kong are eligible for the grant. Current applicants do not need to submit documents, and the government will only require applicants to submit required documents when necessary.

Student grant applications must be **submitted through the school** the student is attending. Each eligible student can only submit **one application**. The subsidy will be paid by the government through **local bank account** transfer declared by parents.

The Education Bureau is now distributing application forms for "student allowance" through schools and verifying student status.

<p>Form B (Pre-printed form)</p>	<p>Suitable for Primary 2 to 6 students who have applied for the student grant</p> <ul style="list-style-type: none"> ➤ Parents/guardians only need to verify the printed information. ➤ If the preprinted information has not been changed, you can add a "✓" sign to the designated confirmation box at the bottom of the form and sign for confirmation. ➤ If part of the information listed in Form B needs to be updated (student's English name, day school name, and information other than school form), parents/guardians should use a black or blue ball pen to make corrections in block letters at the top of the relevant information, and leave the confirmation box blank.

If parents need to apply, please read the "Things to Note" and "Declaration" in the form carefully, then fill in the application form and return it to the class teacher on or before Friday, 30th September, 2022 with the reply slip of this notice. If parents do not wish to apply for the "Student Allowance", they must also return the reply slip and the "Student Grant" application form to the class teacher. Those who do not wish to apply do not need to fill in any information and sign in the application form.
